The aging population and rise in chronic disease rates pose significant challenges to healthcare systems. These trends demand a shift from a system that is well-equipped to deal with acute healthcare issues to so-called "smarter healthcare". This means incorporating aspects of prevention, health promotion and more patient-centered approaches to integrated care. One solution has involved using advance practice

nurses (APNs) to bridge shortfalls in care with a focus on continuum of care, patient engagement and effective use of resources. This symposium will present international perspectives from Canada, the United States, Australia and Switzerland on the roles of advanced nursing practice and their added value in meeting the challenges of chronic disease management and care for the elderly.
